A plan to cover her responsibilities during her absence is being developed. Pastor Renee received a grant toward her sabbatical during the summer of 2024 to include both clergy and congregational renewal. More info. to come.
- Pastor John Kisomo of the 4 point church in Kidamali, TZ will be retiring this October. Plans are in the works to hire his replacement. The GB discussed considering a gift to him and the church to honor his service. Several Shepherd members will be traveling to TZ this winter as part of a Synod group. There may be room if other Shepherd members wish to travel with the group. Please note that travel expenses are paid by the traveler.
